1) Meeting Minutes

• Approval of prior minutes postponed (April 8, April 22, May 6, May 20).

2) Informational Items

Follett Update

- CSUCI is exploring course-by-course textbook access only (not campus-wide).
- Faculty asked to review the June 15 email from Dean Hampton and share with colleagues.
- Concerns noted: unclear student notification process; need consistent Canvas/syllabus language; select pilots (e.g., Psychology) may proceed to evaluate cost savings.

Library Update

- Lighting project will close the library July-mid-August (target reopen for Fall 2025).
- Impacts: summer programming, art gallery, meeting spaces; library flags to be removed as part of the project.
- Chairs should share closure information with colleagues and students.

Staffing Update

- Three temporary positions made permanent: Nursing Clinical Coordinator (Hope L.), Nursing Evaluator (Stephanie C.), and Ivy M. (supporting Political Science, MPA, Psychology).
- Biology: Cathy H. & Jessica D. on CSUEU leave; Sarah B. resigning. Emergency backfills in progress.
- Art: Carlos H. (IST) laid off 6/12/25; exploring emergency hire to maintain operations.
- Physics: Trent R. reduced to 0.5 Physics IST + 0.5 Events in the Provost's Office.
- Campus-wide layoffs totaled 13; no merger with CSUN (rumors dismissed).

Student Fees

- Fall 2025: some course fees may be paused; analysts to verify current balances.
- Memo to Provost/President will recommend which fees to pause; programs should plan to spend down balances by October 2025.
